

2. Online Application and Registration Guide

REGISTRATION STEPS IN THE OPEN EDUCATION SYSTEM



Carefully reading this guide will ensure you complete the registration process accurately and quickly.

STAGE 1

1. ONLINE APPLICATION PROCEDURES

1.1. Online Application and Registration Dates

REGISTRATION TYPE	REGISTRATION DATES
Registration via Selection Exam: (Click here to apply)	July 28 – December 1, 2025
Registration with Diploma Equivalency: (Click here to apply)	July 28 – December 1, 2025
Second University Registration: (Click here to apply)	July 28 – December 1, 2025

*Online application and registration processes for all registration types will begin at 10:00 AM Turkish time on the first day of registration and end at 5:00 PM Turkish time on the last day of registration.

Enrollment via Selection Exam:

Prospective students who have obtained a high school diploma or equivalent from schools in the Republic of Turkey can register by applying to the Selection Exam organized by our University and, if successful, can enroll.

Registration with Diploma

Equivalency: Student candidates who have obtained their high school or equivalent diploma from foreign schools outside the Republic of Turkey can register if they obtain an Equivalency Certificate from the Education Counselors/ Education Attachés within the Turkish Embassies/Consulates or the Provincial National Education Directorates in their region, indicating that they have graduated from a high school or equivalent institution in Turkey.

Second University Enrollment

- Students enrolled in higher education institutions in Turkey,
- Those who have graduated with a bachelor's or associate's degree from higher education institutions in Turkey,
- Individuals who are Turkish citizens, have graduated from higher education institutions abroad, and have obtained an equivalency certificate from the Council of Higher Education, can enroll in a

program outside their field of graduation without an entrance exam through the second university enrollment program.

Candidates enrolling in the Open Education Faculty's Aviation Management Bachelor's Program must also upload to the system at the time of application a document showing that they have no criminal record or criminal archive record that would prevent them from obtaining an airport entry card, and a medical board report from a fully equipped hospital, obtained within the last 6 months, stating that they do not have any health problems (hearing loss/deficiency, vision loss/deficiency, etc.) that would prevent them from performing this profession and/or the duties assigned in this profession.

The Open Education Faculty offers optional preparatory classes in its Business Administration (English), Economics (English), Political Science and Public Administration (English), and International Relations (English) undergraduate programs.

A Turkish Proficiency Certificate is mandatory for international students who choose the Turkish Language and Culture Associate Degree or Turkish Language and Literature Bachelor's Degree programs. Students without a Turkish Proficiency Certificate must attend a compulsory Turkish preparatory class.

Online application and registration dates are indicated above according to the registration type. Applications cannot be submitted online or by any other method after the specified dates. To avoid missing the application deadline for any reason (power outage, technical malfunctions, internet problems, etc.), please submit your application as soon as possible.

- Candidates who do not register between the online application and registration dates cannot claim any right to register later, cannot present any excuses including medical reports, and will lose their right to register.
- Those who do not apply online cannot register. University officials may request original copies of the documents you uploaded to the system during the online application. It should be hidden.

1.2. Online Application Process Steps

aoskayit.anadolu.edu.tr From the address on the Online Application System page;

- Citizens of the Republic of Turkey can start by using the 'Login with e-Government' option with their e-Government passwords. It will strike.
- Citizens of other countries will create an account via the 'Foreign National Entry' and 'Register' options. The email address you use here must be your own and accessible.

When you log in to the Online Application System, you must first create a 'Profile'. After creating your profile, you can submit your application by selecting your registration type and the program (country) you will register for from the 'Final Registration Application' option.

 The uploaded photograph must be taken from the front, with the face clearly visible, and within the last 6 months, allowing for easy identification of the candidate. The candidate is responsible for any negative consequences arising from the uploaded photograph not belonging to them, or being incorrect or invalid, for use by the Open Education Faculty.

1.3. DOCUMENTS REQUIRED FOR REGISTRATION

The required documents for registration are listed below according to the registration type and are explained in detail.

* This applies to programs that accept bank transfer payments (in Africa, Albania, Azerbaijan, Bosnia and Herzegovina, Bulgaria, Indonesia, Iraq, Iran, Kazakhstan, Kyrgyzstan, Kosovo, North Macedonia, Lebanon, Uzbekistan, and Jordan).

This document demonstrates the Turkish language level of international students. TÖMER, ANADOLU TÖMER, Yunus Emre Institute (TYS) exams, and TÖMER certificates from other universities are accepted.

A Turkish Proficiency Certificate is mandatory for all students enrolling in programs in Africa, Australia, Indonesia, and South America (excluding programs where the language of instruction is English).

For other international programs, a Turkish Proficiency Certificate is mandatory for foreign students who choose the "Turkish Language and Culture" and "Turkish Language and Literature" departments.

1.4. Educational Status Certificate

1.4.1. Selection Exam and Diploma Equivalency (Candidates Whose MEBBÝS Information Cannot Be Retrieved)

The educational document demonstrating that you have graduated from high school or equivalent can be one of the following when applying for online registration:

- **Certified Copy of High School Diploma:** Graduates of the Turkish education system must upload a certified copy of their high school diploma, approved by the Education Counselors/Education Attachés within Turkish Embassies/Consulates, or by Turkish Notaries.

Verifiable (barcoded) documents obtained from the e-Government system or the school of graduation are valid.

- **Certified Copy of Provisional Graduation Certificate:** Students who have recently graduated from the Turkish Education System (High School) but have not yet received their diplomas can obtain a certified copy of the provisional graduation certificate from their school and submit it to the Education Attachés' Offices within the Turkish Embassies.

They will upload a certified copy, issued by the Education Attachés within the Consulates General or by Turkish Notaries, to the system.

Verifiable (barcoded) documents obtained from the e-Government system or the school of graduation are valid.

- **Certified Copy of Equivalency Certificate:** For student candidates who completed their high school education abroad, this is a certified copy of the equivalency certificate showing that they have graduated from a high school or equivalent institution in Turkey. The equivalency process is carried out by the Turkish Ministry of National Education, Board of Education/Provincial Directorates of National Education/Turkish Republic authorities in the country where the student is located. This process is handled by Education Counselors/Turkish Republic Education Attachés. Equivalency certificates are issued by these offices.

6. Online Application and Registration Guide

Turkish Embassies/Education Attachés or Turkish Consulates will upload a certified copy of their equivalency certificate to the system. A verifiable (barcoded) equivalency certificate is valid.

- **Undertaking:** Candidates who cannot prepare certified copies of their High School Diploma, Provisional Graduation Certificate, Equivalency Certificate, and University Diploma will create an Undertaking during the online application steps, print it out, read it, sign it with a ballpoint pen, and upload it, stating that they will submit the aforementioned documents by January 30, 2026.
- **Turkish Language Proficiency Certificate:** This document demonstrates the international student's level of Turkish language proficiency. TÖMER, ANADOLU TÖMER, Yunus Emre Institute (TYS) exams, and TÖMER certificates from other universities are accepted. Students who are citizens of the Republic of Turkey must upload their Turkish Republic identity card.

Copies of the aforementioned educational documents certified by institutions or organizations other than the Education Counselors within the Turkish Embassies/Education Attachés within the Turkish Consulates General or Turkish Notaries will not be accepted.

 Discontinuation certificates, temporary equivalency certificates, plain texts indicating graduation, basic course completion diplomas, achievement certificates, and other certificates are absolutely not considered equivalent to graduation certificates, and registration will not be accepted with these documents.

1.4.2. Second University

Candidates whose educational information cannot be accessed in YÖKSÜS must enter the document (barcode) number located in the upper right corner of their student/graduate certificate, obtained through the e-Government portal, completely and accurately in order to continue their online application. Candidates who cannot access their student/graduate certificate through the e-Government portal must update their YÖKSÜS information by applying to the relevant higher education institution where they are registered/graduated.

1.5. Residence Permit

1.5.1. Student Candidates Applying to the European Programme

- Turkish citizens registering for the European Program will create a Final Registration Information Form online during the application process, using the information on their passport and identity card, and will print it out from the registration page. The form contains information about passport, identity card, address, and residence permit. The form, which will be filled out according to the information on the passport and identity card, will be certified by the Education Counselors within the Turkish Embassies/Education Attachés within the Turkish Consulates or by Turkish Notaries. Therefore, candidates must go to the Turkish Embassy or Consulate to which they are affiliated with their passport and identity card to have the form certified. The certified form must be uploaded to the registration page. The original copy of the form you upload to the system should be kept safe as it may be requested by university officials.
- Non-Turkish citizens must upload a certified copy of their Turkish Republic Identity Card with photo/at least 6-month residence permit instead of the Final Registration Information Form; this copy must be certified by the Education Counselors at Turkish Embassies/Education Attachés at Turkish Consulates or by Turkish Notaries. The original of the document you upload to the system should be kept safe as it may be requested by university officials.

1.5.2. Student Candidates Applying to Other International Programs

Applicants must upload a certified copy of their Photo ID Card, Residence Permit valid for at least 6 months, or Visa valid for at least 6 months, to the system. This copy must have been certified by the Education Counselors/Education Attachés within the Turkish Embassies/Consulates or by a Turkish Notary Public.



Individuals traveling abroad on tourist visas and those without citizenship (refugees) cannot register using their issued travel documents.

1.6. Term Teaching Material Fee Payment Receipt

Candidates registering for the program must pay the Semester Teaching Material Fee, determined by Anadolu University in accordance with the relevant Presidential Decree, after completing the online application process. This fee covers examination services, materials, and other services. The Semester Teaching Material Fee must

be paid after preparing all required documents requested in the online application. For programs where payment is made via bank transfer, a payment document for tuition fees will be created with the bank receipt/delivery note. The student's Turkish Republic Identity Number/student number and full name must be clearly written in the "description" section of the bank receipt/delivery note.

1.7. Candidates Uploading Required Document(s) for Registration

Your registration confirmation process will be completed within a few days by the Registration Centers after reviewing the suitability of your documents. Documents deemed unsuitable will be returned so you can upload the correct documents within the registration period. Registration automation (aoskayit.anadolu.edu.tr) You need to check your registration approval status under the "My Applications" option.

Once your registration is confirmed, your student password will be sent to the email address you provided during registration. You can access your account at aosogrenci.anadolu.edu.tr using your student password. The address is ekampus.anadolu.edu.tr, which is your Student Information System page and Learning Portal. You can log in to this address.



Candidates can check their application status via the Registration Automation system (aoskayit.anadolu.edu.tr) They should check via the "My Applications" link.



Original copies of the documents you uploaded to the system during the online application process must be kept safe, as university officials may request them.

STAGE 2

2. Payments Required for Registration

2.1. Term Teaching Material Fee

Candidates registering will pay the Semester Teaching Material Fee, determined by Anadolu University, which covers examination services, materials, and other services in accordance with the relevant Presidential Decree.

Those whose registration has been cancelled from the Open Education Faculty for any reason, as well as those who have graduated from these programs, must pay any outstanding debts from their previous program before they can re-register with these faculties.



Once the registration process is complete, the Term Teaching Material Fee is non-refundable.

2.2. Payment Methods

For programs where payment is made via bank transfer (Africa, Albania, Azerbaijan, Bosnia and Herzegovina, Bulgaria, Indonesia, Iraq, Iran, Kazakhstan, Kyrgyzstan, Kosovo, North Macedonia, Lebanon, Uzbekistan, and Jordan), a "Bank Statement" document for the Semester Teaching Material Fee will be generated during the online application process. This document will include the bank details for payment and the Semester Teaching Material Fee amount. When making the payment, it is essential to include your Turkish Republic Identity Number/student number and your full name in the "description" section of the Bank Statement/Receipt.



When paying by bank transfer, the student's full name and Turkish Republic ID/student number must be clearly written in the description section of the payment slip. All bank transfer fees are the responsibility of the student.

For programs that accept credit card payments (Europe, Australia, United Arab Emirates, South America, Montenegro, Qatar, North America, Egypt, Moldova, Romania, Serbia, and Saudi Arabia), the Term Teaching Material Fee will be paid during the online application process.

- Anadolu University is not responsible for any consequences arising from the failure to make timely or incorrect registration payments. The responsibility for any incorrect payment lies with the applicant.
- Keep your bank receipt throughout your studies. The receipt will be sent to University officials later.
It may be requested.
- Once payment is made, registration cannot be cancelled and the amount paid is non-refundable.
- For online applicants (excluding relatives of martyrs and veterans) who have uploaded documents, payment of the amount specified during registration is required in order for document verification and registration to be completed.

2.3. Students Who Will Not Be Charged for Term Teaching Materials

2.3.1. Students Covered by Various Laws

In accordance with the Anadolu University Board of Directors Decision No. 1/26 dated 03.01.2019, the Semester Teaching Material Fee will not be collected from the parents, spouses, and children of those who lost their lives while performing their duties under the laws listed below;

- Article 47 of the Social Security and General Health Insurance Law No. 5510 dated 31.05.2006
Article n,
- Law No. 2330 on Monetary Compensation and Monthly Pension Entitlement, dated 03.11.1980,
- Law No. 2453 dated 23.04.1981 concerning the Payment of Monetary Compensation and Monthly Allowances to Personnel Serving Abroad,
- Flight, Parachute, Submarine, Diver and Frogman Services, dated 28.02.1982 and numbered 2629 Compensation Law,
- Law No. 3713 on Combating Terrorism, dated April 12, 1991.

Moreover;

- Disabled persons covered under the Anti-Terrorism Law No. 3713 dated 12.04.1991 and the Law No. 2330 on Monetary Compensation and Monthly Pension Payments, as well as their parents, spouses and children,
- Those receiving an honorary pension under the Law No. 1005 dated 24.02.1968 concerning the granting of honorary pensions from the National Service Scheme to those awarded the Independence Medal, as well as their parents, spouses, and children, will not be charged the Term Teaching Material Fee, regardless of age.

Students falling under the scope of the laws listed above are exempt from the Semester Teaching Material Fee and therefore will not be required to pay it.



Students covered by various laws must upload their Certificate of Entitlement, obtained from the Social Security Institution, to the system during the application process. The relevant legal article must be included in the document. Only Martyr/Veteran Identity Cards are not valid.

Students covered by various laws must upload documents according to the explanations below.

- The uploaded document must include the relevant legal article.
- It should be clearly stated in the document that no Term Teaching Material Fee will be charged to the mothers, fathers, spouses and children of those who lost their lives while performing their duties within the scope of Law No. 5510 (5434).
- Applications from those who only upload Martyr and Veteran identity documents will be rejected.
- Students covered by various laws must upload their Certificate of Entitlement from the Social Security Institution to the system during the application process. The relevant legal article must be included in the document. Only the Martyr/Veteran Identity Card is not valid.

The document uploaded by the candidate will be checked, and if found acceptable, the registration will be completed. If the document is not accepted, a suitable document must be uploaded again within the registration period.

2.3.2. Students with Disabilities

Student candidates with a disability rate of 40% or higher must document their condition with a Health Board Report obtained from a fully equipped hospital in Türkiye. A discount will be applied to student candidates with a disability rate of 40% or higher.

The document uploaded by the candidate will be checked, and if found acceptable, the registration will be completed. If the document is not accepted, a suitable document must be uploaded again within the registration period.

2.3.3. Term Teaching Material Fee Refund Procedures

Students who have made duplicate and/or excessive payments, as well as students with disabilities or those covered by the laws listed in the Council of Ministers' Decree, must apply in writing to receive a refund of the amount they paid for semester teaching materials.

The refund request application must include the bank and branch name and the student's IBAN number. Applications with incomplete information will not be processed. The original application form and bank receipt must be sent to Anadolu University Open Education Faculty, International Programs Unit, Floor 1, Yunus Emre Campus, 26470 Tepebaşı-Eskişehir/TURKEY within the registration period.

Applications submitted via email or fax will not be considered.

STAGE 3

3. REGISTRATION WARNINGS

- Student candidates who are citizens of the Republic of Turkey can complete their online application process via "e-Government". They will log in using their e-Government password via the "Login" link.
- Citizens of other countries will create an account via the 'Foreign National Entry' and 'Register' options. The email address you use here must be registered and accessible to the applicant.
- The candidate must fill in all relevant fields on the online application page completely and accurately. is required.
- The documents required for registration must meet the specifications outlined in this guide.
- Registration will not be processed with incomplete documents, and no additional time will be given to complete the required documents.
- Candidates who submit their registration documents without first applying online will not be registered.
- Students registering are responsible for the accuracy of the information in the documents they upload to the system. The documents uploaded to the system will be examined to ensure they comply with the principles and rules defined in this guide, and if any missing or incorrect documents are found, students will be asked to re-upload them.
- Original copies of the documents you uploaded to the system during the online application process will be examined by university officials. It needs to be kept safe because it might be requested.
- Students currently enrolled in a program at the Open Education Faculty must cancel their current registration in order to enroll in another program in the 2025-2026 academic year.

- Our students' registration date is the date they register with the Faculty. They can receive student services from the registration date onwards.
- Students who register for the Fall Semester of the 2025-2026 Academic Year will have their Fall Semester courses uploaded through the system. If they wish to continue their studies, they must renew their registration by selecting their courses during the Spring Semester registration renewal dates.

4. UNITS TO BE COVERED IN TEXTBOOKS AND EXAMS

Textbooks, which are an effective and efficient material for self-learning and have been used as basic teaching material since their inception, are prepared by an expert team with a very strong technical infrastructure.

Textbooks are provided to students in digital (PDF) format. Students are responsible for the content of the current version (PDF) of the textbook available on the Anadolu e-Campus platform during exams. Other course materials offered on the Anadolu e-Campus platform (Unit Summaries, Learn Through Questions, Unit Summary Videos, Worksheets, etc.) are digital resources that aid learning. Students can access these resources at ekampus.anadolu.edu.tr Digital textbooks can be accessed from the "My Courses" section by logging in with your Turkish ID/student number and password at [website address].

The units to be covered in the exams can be found at www.anadolu.edu.tr/acikogretim Exam Information at this address [Exam Responsibility Units](#) of the Department It is published on the page.

Our students living in Germany, Austria, Belgium, Denmark, France, the Netherlands, England, Switzerland, and Italy can visit bookstore.anadolu.edu.tr They can purchase printed books through this address.

Purchased textbooks are shipped to the address provided by the student via a paid courier service.

5. COURSE TRANSFER AND EXEMPTION PROCEDURES

Course transfer and exemption procedures are governed by the "Principles of Course Transfer and Exemption in Open Education Faculties". This is carried out accordingly. Detailed information on how to apply for exemption can be found on globalcampus. Further information will be announced on the Announcements section of anadolu.edu.tr.

6. EXAMINATION PROCEDURES FOR STUDENTS WITH DISABILITIES

Students with physical disabilities such as visual, hearing, or mobility impairments, if they have a request to be excused from the exam, should submit their detailed application, in accordance with the Health Board Report, to bap@anadolu.edu.tr after completing their registration for European Programs. Students enrolled in other international programs should send their applications to globalcampus@anadolu.edu.tr. They need to notify us via email.

Students can check if their disability status has been processed in their faculty registration by visiting aosogrenci.anadolu.edu.tr. Students must check their information by logging into the Student Information System website using their Turkish Republic Identity Number/student number and password.



Students whose exam status does not appear to be a disability will be allowed to take the exam with other students.
