## REGISTRATION STEPS IN THE OPEN EDUCATION SYSTEM



Carefully reading this guide will ensure you complete the registration process accurately and quickly.

## STAGE 1

### 1. ONLINE APPLICATION PROCEDURES

#### 1.1. Online Application and Registration Dates

*\*Online application and registration processes for all registration types will begin at 10:00 AM Turkish time on the first day of registration and end at 5:00 PM Turkish time on the last day of registration.*



#### Registration with Diploma Equivalency:

Student candidates who have obtained their high school or equivalent diplomas from schools abroad, outside of the Republic of Turkey and the Turkish Republic of Northern Cyprus, can apply to the Education Attachés/Education Counselors within the Turkish Embassies in their region/region.

Those who obtain an Equivalency Certificate from the Education Attachés within the Consulates General or from the Provincial National Education Directorates, indicating that they have graduated from a high school or equivalent institution in Türkiye, can register.



#### Second University Enrollment

- Students enrolled in higher education institutions in Turkey,
- Those who have graduated with a bachelor's or associate's degree from higher education institutions in Turkey,
- Those who are Turkish citizens, have graduated from higher education institutions abroad, and have obtained an equivalence certificate from the Council of Higher Education.

They can enroll in a department outside their field of graduation without taking an entrance exam, through the second university enrollment type.

Candidates enrolling in the Open Education Faculty's Aviation Management Bachelor's Program must also upload to the system at the time of application a document showing that they have no criminal record or criminal archive record that would prevent them from obtaining an airport entry card, and a medical board report from a fully equipped hospital, obtained within the last 6 months, stating that they do not have any health problems (hearing loss/deficiency, vision loss/deficiency, etc.) that would prevent them from performing this profession and/or the duties assigned in this profession.

The Open Education Faculty offers optional preparatory classes in its Business Administration (English), Economics (English), Political Science and Public Administration (English), and International Relations (English) undergraduate programs.

A Turkish Proficiency Certificate is mandatory for international students who choose the Turkish Language and Culture Associate Degree or Turkish Language and Literature Bachelor's Degree programs. Students without a Turkish Proficiency Certificate must attend a compulsory Turkish preparatory class.

Online application and registration dates are indicated above according to the registration type. Applications cannot be submitted online or by any other method after the specified dates. To avoid missing the application deadline for any reason (power outage, technical malfunctions, internet problems, etc.), please submit your application as soon as possible.



- Candidates who do not register between the online application and registration dates cannot claim any right to register later, cannot present any excuses including medical reports, and will lose their right to register.
- Those who do not apply online cannot register. Applying is not sufficient for registration. After making the payment, the applicant (except for disabled individuals, relatives of martyrs and veterans with additional information) must confirm their registration on the application page to complete the process.
- Candidates enrolling under the second university program must update their educational information. Candidates who cannot access their current YÖKSİS information will not be able to complete their online application.
- Online application and registration procedures for candidates who are detained/imprisoned in jail. This will be done by the prison education officer.

## 1.2. Online Application Process Steps

[aoskayit.anadolu.edu.tr](https://aoskayit.anadolu.edu.tr) From the Online Application System page;

- Citizens of the Republic of Turkey can start by using the 'Login with e-Government' option with their e-Government passwords. It will strike.
- Citizens of other countries will create an account via the 'Foreign National Entry' and 'Register' options. The email address you use here must be your own and accessible.

When you log in to the registration automation system, you must first create a 'Profile'. After creating your profile, you can submit your application by selecting your registration type and the program (country) you will register for from the 'Final Registration Application' option.



The uploaded photograph must be taken from the front, with the face clearly visible, and within the last 6 months, allowing for easy identification of the candidate. The candidate is responsible for any negative consequences arising from the uploaded photograph not belonging to them, or being incorrect or invalid, for use by the Open Education Faculty.

## 2. DOCUMENTS REQUIRED FOR REGISTRATION

The required documents for registration are listed below according to the registration type and are explained in detail.

Second University:	

*\*\*This document demonstrates the Turkish language proficiency level of international students. TÖMER, ANADOLU TÖMER, Yunus Emre Institute (TYS) exams, and TÖMER certificates from other universities are accepted. Students with Turkish Republic and Northern Cyprus citizenship must upload their national identity cards.\*\**

Original copies of the documents you uploaded to the system during the online application process may be requested by university officials, so they must be kept safe along with other documents.

### 2.1. Educational Status Certificate

#### 2.1.1. Diploma Equivalency

In the online registration application

- **Certified Copy of Equivalency Certificate:** For student candidates who completed their high school education outside the Republic of Turkey or the Turkish Republic of Northern Cyprus, this is a certified copy of the equivalency certificate showing that they graduated from a high school or equivalent institution in Turkey. The equivalency process is carried out by the Turkish Ministry of National Education, Board of Education/Provincial Directorates of National Education/Turkish Education Counselors/Turkish Education Attachés in the respective countries. Applicants will upload certified copies of their equivalency certificates, approved by Education Counselors within Turkish Embassies/Education Attachés within Turkish Consulates General or by Turkish Notaries, to the system.  
It is not necessary to have the verifiable (barcoded) equivalence certificate certified.
- **Undertaking:** Candidates who cannot prepare certified copies of their High School Diploma, Provisional Graduation Certificate, Equivalency Certificate, and University Diploma will create an Undertaking during the online application steps, print it out, read it, sign it with a ballpoint pen, and upload it, stating that they will submit the aforementioned documents by January 30, 2026.
- **Turkish Language Proficiency Certificate:** This document demonstrates the international student's level of Turkish language proficiency. TÖMER, ANADOLU TÖMER, Yunus Emre Institute (TYS) exams, and TÖMER certificates from other universities are accepted. Students who are citizens of the Republic of Turkey and the Turkish Republic of Northern Cyprus must upload their citizenship identity card.

Copies of the aforementioned educational documents certified by institutions or organizations other than the Education Counselors within the Turkish Embassies/Education Attachés within the Turkish Consulates General or Turkish Notaries will absolutely not be accepted.



Discontinuation certificates, temporary equivalency certificates, plain texts indicating graduation, basic course completion diplomas, achievement certificates, and other certificates are absolutely not considered equivalent to graduation certificates, and registration will not be accepted with these documents.

### 2.1.2. Second University

Candidates whose educational information cannot be accessed in YÖKS S must enter the document (barcode) number located in the upper right corner of their student/graduate certificate, obtained through the e-Government portal, completely and accurately in order to continue their online application. Candidates who cannot access their student/graduate certificate through the e-Government portal must update their YÖKS S information by applying to the relevant higher education institution where they are registered/graduated.

## 2. Residence Permit

Student applicants must upload to the system certified copies of their Photo ID Card, Residence Permit valid for at least 6 months, or Visa valid for at least 6 months, approved by the Education Counselors at Turkish Embassies/Education Attach s at Turkish Consulates, or by Turkish Notaries.



Individuals traveling abroad on tourist visas and those without citizenship (refugees) cannot register using their issued travel documents.

## STAGE 2

## 3. Payments Required for Registration

### 3.1. Semester Student Contribution Fee :

According to the Presidential Decree on the Determination of Contribution Fees and Tuition Fees to be Collected as Student Contributions to Current Service Costs in Higher Education Institutions in the 2025-2026 Academic Year, published in the Official Gazette dated July 9, 2025, and numbered 32951, no semester student contribution fee will be collected from candidates registering for the program.

However, in accordance with Article 10-(3) of the Presidential Decree published in the Official Gazette dated 09.07.2025 and numbered 32951; "The student contribution fee for only one program in which the student is registered is covered by the State. If a student is registered in a second higher education program (excluding double major programs) while registered in a higher education program in a State Higher Education Institution, the student contribution fees for the second program are covered by the students themselves.", candidates will pay the Semester Student Contribution Fee.

### 3.2. Term Teaching Material Fee

After completing the online application process, candidates registering for the exam will pay the Semester Teaching Material Fee, determined by Anadolu University in accordance with the relevant Presidential Decree, which covers exam services, materials, and other services.

The payment receipt/credit card/debit card payment confirmation printout must be checked carefully, including the identification information, payment amount, registration type, and program information. Registration will not be possible if payment is made for a registration type or program other than the one you are registering for.

Those whose registration has been cancelled from the Open Education Faculty for any reason, as well as those who have graduated from programs, must pay any outstanding debts from their previous program before they can re-register with the Open Education Faculty.



Once the registration process is complete, the Term Tutorial Material Fee and Term Student Contribution Fee are non-refundable.

In the 2025-2026 academic year, programs taught in Turkish will cost 3,500.00 TL, and programs taught in English will cost 4,500.00 TL.

Turkish citizens aged 60 and over who enroll in the Open Education Faculty will receive a 60% discount on the Semester Tuition Fee.

### 3.3. Payment Methods

You can make the required registration payments through Ziraat Bank using one of the following payment methods:

- Payment by Credit Card/Debit Card •
- Payment via Internet Banking •
- Payment via ATM (with/without card)
- Payment via Mobile Banking

Payments will close at 5:20 PM on the last day of the registration period.



Payments cannot be made through Ziraat Bank branches.

Payments made via postal money order, bank transfer, and EFT are not accepted.

- Anadolu University is not responsible for any consequences arising from late or incorrect payments related to registration. The responsibility for incorrect payments lies with the applicant.
- Keep your receipt/credit card/debit card payment confirmation printout throughout your studies. These documents may be requested later by university officials.
- Once payment is made, registration cannot be cancelled and the amount paid is non-refundable. • Candidates who apply online (excluding those with additional information such as disabled individuals, relatives of martyrs and veterans) and upload documents must pay the registration fee so that the Open Education Faculty can verify their documents and complete their registration.





After making the payment, the applicant (except for those with additional information such as disabled individuals, relatives of martyrs and veterans) must confirm their registration on the application page to complete the process. Registrations of applicants who do not confirm their registration will be completed by the system.

### 3.4. Students Exempt from Semester Teaching Material Fee 3.4.1. Students Covered by

**Various Laws** In accordance with the Anadolu University Board of

Directors Decision No. 1/26 dated 03.01.2019, the Semester Teaching Material Fee will not be collected from the parents, spouses, and children of those who lost their lives while performing their duties under the laws listed below;

- Article 47 of the Social Security and General Health Insurance Law No. 5510 dated 31.05.2006 Article n,
- Law No. 2330 on Monetary Compensation and Monthly Pension Entitlement, dated 03.11.1980,
- Law No. 2453 dated 23.04.1981 concerning the Payment of Monetary Compensation and Monthly Allowances to Personnel Serving Abroad,
- Flight, Parachute, Submarine, Diver and Frogman Services, dated 28.02.1982 and numbered 2629 Compensation Law,
- Law No. 3713 on Combating Terrorism, dated April 12, 1991.

Moreover;

- Disabled persons covered under the Anti-Terrorism Law No. 3713 dated 12.04.1991 and the Law No. 2330 on Monetary Compensation and Monthly Pension Payments, as well as their parents, spouses and children,
- Those receiving an honorary pension under the Law No. 1005 dated 24.02.1968 concerning the granting of honorary pensions from the National Service Scheme to those awarded the Independence Medal, as well as their parents, spouses, and children, will not be charged the Term Teaching Material Fee, regardless of age.

Students falling under the scope of the laws listed above are exempt from the Semester Teaching Material Fee and therefore will not be required to pay it.



Students covered under various laws must upload a Certificate of Entitlement obtained from the Social Security Institution within the last 6 months to the system during the application process. The relevant legal article must be included in the document. A Martyr/Veteran Identity Card alone is not valid.

Students covered by various laws must upload documents according to the explanations below.

- The uploaded document must include the relevant legal article.
- It should be clearly stated in the document that no Term Teaching Material Fee will be charged to the mothers, fathers, spouses and children of those who lost their lives while performing their duties within the scope of Law No. 5510 (5434).
- Applications from those who only upload Martyr and Veteran identity documents will be rejected.

The documents uploaded to the system by the candidate will be checked by the Open Education Faculty, and if found suitable, the registration will be completed.

If the document is not accepted, the correct document must be uploaded again within the registration period.

### 3.4.2. Students with Disabilities:

In accordance with Anadolu University Board of Directors Decision No. 1/27 dated 03.01.2019, students with a disability rate of 40% or more will not be charged the Semester Teaching Material Fee.

The issuance, validity, evaluation of the Disability Health Board Report (ESKR/ÇÖZGER), and the identification of authorized health institutions and organizations that can issue this report, are governed by the Regulation on Disability Assessment for Adults and the Regulation on Special Needs Assessment for Children, both published in the Official Gazette dated February 20, 2019, and numbered 30692.

Students with a disability rate of 40% or higher must document their condition with a Medical Board Report.

Students in this situation are exempt from the Semester Teaching Material Fee and therefore will not have to pay it. Students must upload a Health Board Report indicating their disability rate to the system during the application process.

The documents uploaded to the system by the candidate will be checked by the Open Education Faculty, and if found suitable, the registration will be completed.

If the document is not accepted, the correct document must be uploaded again within the registration period.

### 3.4.3. Term Teaching Material Fee Refund Procedures

Students who are disabled or fall under the scope of the laws listed in the Presidential Decree and who have paid the semester tuition fee/semester student contribution fee and semester teaching material fee must send a signed petition stating their request for a refund and their IBAN number from any bank account to the following address: "Anadolu University Open Education Faculty International Programs Unit Yunus Emre Campus 26470-ESK  EH  R". Applications made via email or fax will not be considered.

## 4. Candidates who uploaded the required document(s) for registration.

Candidates who upload the required documents and pay the registration fee during the online application process will have their documents checked by the Open Education Faculty, and if found suitable, their registration will be completed.

If the Open Education Faculty deems the document uploaded by the applicant unsuitable, the application will not be completed, and the applicant will be informed to upload the correct document.

Applicants should check their application status via the "Online Application Page," under the "My Applications" link.

If the candidate uploads the correct document within the registration period, the document will be re-checked by the Open Education Faculty, and if found suitable, the registration will be completed.

Once your registration is confirmed, your student password will be sent to the email address you provided during registration. You can access your account at [aosogrenci.anadolu.edu.tr](https://aosogrenci.anadolu.edu.tr) using your student password. The address is [ekampus.anadolu.edu.tr](https://ekampus.anadolu.edu.tr), which is your Student Information System page and Learning Portal. You can log in to this address.



Candidates can check their application status via the Registration Automation system ([aoskayit.anadolu.edu.tr](https://aoskayit.anadolu.edu.tr)) They should check via the "My Applications" link.

Original copies of the documents you uploaded to the system during the online application process may be requested by university officials, so they must be kept safe along with other documents.

## STAGE 3

### 4. REGISTRATION WARNINGS

- Student candidates who are citizens of the Republic of Turkey can complete their online application process via "e-Government". They will log in using their e-Government password via the "Login" link.  
  
Citizens of other countries will create an account via the 'Foreign National Entry' and 'Register' options. The email address you use here must be your own and accessible.
- Before applying, your educational information must be up-to-date in the YÖKSYS system. Candidates whose information is not up-to-date should contact their registered institutions to have their information updated.
- The candidate must fill in all relevant fields on the online application page completely and accurately. is required.
- The documents required for registration must meet the specifications outlined in this guide.
- Registration will not be processed with incomplete documents, and no additional time will be given to complete the required documents.
- Registrations of candidates who submitted their registration documents by mail without applying online will be processed. It will not be done.
- Students registering are responsible for the accuracy of the information in the documents they upload to the system. The documents uploaded to the system will be examined to ensure they comply with the principles and rules defined in this guide, and if any missing or incorrect documents are found, students will be asked to re-upload them.
- Students currently enrolled in a program at the Open Education Faculty must cancel their current registration in order to enroll in another program at our Faculty in the 2025-2026 academic year.
- Our students' registration date is the date they register with the Faculty. They can receive student services from this date onwards.
- Students who register for the Fall Semester of the 2025-2026 Academic Year will have their Fall Semester courses uploaded through the system. If they wish to continue their studies, they must renew their registration by selecting their courses during the Spring Semester registration renewal dates.

## 5. UNITS TO BE COVERED IN TEXTBOOKS AND EXAMS

Textbooks, which are an effective and efficient material for self-learning and have been used as basic teaching material since their inception, are prepared by an expert team with a very strong technical infrastructure.

Textbooks are provided to students in digital (PDF) format. Students are responsible for the content of the current version (PDF) of the textbook available on the Anadolum eCampus platform during exams. Other course materials offered on the Anadolum eCampus platform (Unit Summaries, Learn Through Questions, Videos, Audio Materials, etc.) are supplementary learning resources. Students can access digital textbooks from the "My Courses" section by logging in at [ekampus.anadolu.edu.tr](http://ekampus.anadolu.edu.tr).

The units that will be covered in the exams are published on the Exam Responsibility Units page of the Exams Information section at [www.anadolu.edu.tr/acikogretim](http://www.anadolu.edu.tr/acikogretim).

Students who wish to obtain textbooks in printed format instead of digital format can create an account at [kitapsatis.anadolu.edu.tr](http://kitapsatis.anadolu.edu.tr) and then pay with a bank card or credit card. The purchased textbooks are sent to the address specified by the student via paid courier.

## 6. COURSE TRANSFER AND EXEMPTION PROCEDURES

Course transfer and exemption procedures are carried out according to the "Open Education Faculty Course Transfer and Exemption Principles". Detailed information can be found at [www.anadolu.edu.tr/acikogretim](http://www.anadolu.edu.tr/acikogretim) during the relevant registration dates. It will be published in the Announcements section of [website address].

## 7. EXAMINATION PROCEDURES FOR STUDENTS WITH DISABILITIES

Students with visual, hearing, mobility, physical, etc. disabilities who wish to take the exam with a disability exemption can do so in detail via aösdestek after completing their registration, in accordance with the Health Board Report. Students must report this to [anadolu.edu.tr](http://anadolu.edu.tr) under the category "Disadvantaged and Disabled Students".

Students must check whether their disability status has been processed in their faculty registrations by logging into the Student Information System at [aof.anadolu.edu.tr](http://aof.anadolu.edu.tr) using their Turkish Republic ID number and password.



Students whose exam status does not appear to be a disability will be allowed to take the exam with other students.



In accordance with the Law No. 4982 on the Right to Information, it is important to note that applications concerning the rules and decisions explained in this guide will not be considered.



The programs, program scopes, teaching methods, rules, and procedures included in the Online Application, Registration, Re-registration, and Student Guides may be changed in accordance with the decisions taken by the legislative, executive, and judicial bodies, as well as the Higher Education Council, the Rectorate of Anadolu University, and the authorized boards of the Open Education Faculty. The announced procedures will be carried out in accordance with the new decisions.
